

The Ireland to Transfer Discount and 0 fee Transaction Promotion

Terms and Conditions:

- To be eligible for **Ireland to Transfer Discount and 0 fee Transaction** promotion ("Promotion") you must sign up for Remitly via Remitly's transfer discount and 0 fee transaction-branded landing page and successfully complete your first transfer of or more to (i.e. a "qualifying transfer"). Please note that your discount amount will not count towards the minimum spend requirements.

- A transfer is considered "successfully completed" when funds are deposited into your intended recipient's bank account; are picked up by your recipient at a cash pick-up location; properly delivered to the recipient and/or deposited into the recipient's mobile wallet (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- **The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer. This is a limited time offer.**

- Remitly reserves the right to limit the number of individuals per household eligible for this Promotion.
