

## **The \$5 Transfer Discount and Free Transaction Promotion**

### **Terms and Conditions:**

- To be eligible for the \$5 Transfer Discount and Free Transaction promotion ("Promotion") you must sign up for Remitly via Remitly's friend referral-branded landing page and successfully complete your first transfer of \$50 or more to (i.e. a "qualifying transfer"). Please note that your discount amount will not count towards the minimum spend requirements.

- A transfer is considered "successfully completed" when funds are deposited into your intended recipient's bank account; are picked up by your recipient at a cash pick-up location; properly delivered to the recipient and/or deposited into the recipient's mobile wallet (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- **The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer. This is a limited time offer.**

- Remitly reserves the right to limit the number of individuals per household eligible for this Promotion. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins and/or any other methods will void and disqualify the customer from receiving the Promotion at Remitly's sole discretion.

The \$5 transfer discount and free transaction will be applied by Remitly directly to your qualifying transfer and will be available only to that transfer if it is successfully completed. Transfers submitted outside of the Promotion Period will not be eligible for this Promotion.

- Failure to send over \$50 or more on your first transfer will render you ineligible for this Promotion or other promotions that may be run for first time customers.

- The transfer discount and free transaction cannot be used on subsequent transfers. The transfer discount and free transaction have no cash value.

- Your election to participate in the Promotion will render you ineligible for participation in other promotions that Remitly may run and that you may otherwise have been eligible for. Your election to participate in the Promotion is final.
