

The \$500 to \$1,000 to Transfer Discount and 0 fee Transaction Promotion

Terms and Conditions:





The \$500 transfer discount and 0 fee transaction will be applied by Remitly directly to your qualifying transfer and will be available only to that transfer if it is successfully completed. Transfers submitted outside of the Promotion Period will not be eligible for this Promotion.

- Failure to send over \$500 or more on your first transfer will render you ineligible for this Promotion or other promotions that may be run for first time customers.

- The transfer discount and 0 fee transaction cannot be used on subsequent transfers. The transfer discount and 0 fee transaction have no cash value.
