

## **The [REDACTED] to Transfer Discount and Free Transaction Promotion**

### **Terms and Conditions:**

- To be eligible for the Transfer Discount and Free Transaction Promotion ("Promotion") you must: sign in via the screen which linked you to these terms and successfully complete a transfer to .

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the cash sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- **The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.**

- The transfer discount will be applied by Remitly directly to your qualifying transfer and will be available only to that transfer if it is successfully completed. Please note that your discount amount will not count towards the minimum spend requirements. The transfer discount cannot be used on subsequent transfers.

- The fee free transfer will be directly applied to your first successfully completed transaction. Fee free transfer(s) do not apply to transactions made with credit cards.

Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods will void and disqualify the customer from receiving the Promotion at Remitly's sole discretion (acting reasonably).

- If you are entitled to any refund, you will not be entitled to receive any amount greater than the amount you have paid to make the money transfer.
